DEFINITION: This position is responsible for inspecting permitted issued sites to ensure that residential and commercial structures are in compliance with the NC Building Codes and County Ordinances.

REPORTS TO: Director of Planning, Inspections & E-911 Addressing Department

JOB REQUIREMENTS:

- Performs inspections of residential, commercial and industrial building projects for compliance with North Carolina building, electrical, plumbing or mechanical codes.
- Enforcing minimum housing and FEMA/flood plain and other ordinances as assigned,
- Responds to citizen complaints; notifies citizens and contractors of minimum code regulations.
- Reviews architectural plans and figures permit costs.
- Notifies appropriate parties of defects.
- Advises contractors in applying code regulations.
- Approves certificates of occupancy.
- Checks minimum housing code complaints.
- Issues stop work orders.
- Checks and verifies contractor license numbers.
