## **POSITION DESCRIPTION: -**

This position is located on Team II in Child Protective Services. The primary purpose of this position is to provide intensive indepth services for a limited caseload of children who are at risk of being removed from their homes due to abusive or neglectful treatment. Services provided include children who have been placed in the foster care system by the court due to unsubstantiated abuse, neglect and/or dependency. This position performs other duties as assigned. A valid NC driver's license and access to a passenger vehicle is required. Employees operating their personal vehicles for county business shall maintain the minimum liability coverage required by the state of North Carolina in accordance to the County Fleet Policy and Employee Safety Program (page 10. Section G.). Position is located in Tarboro; however, office location may change based on the needs of the agency.

#### **KNOWLEDGES. SKILLS AND ABILITIES:**

Thorough knowledge of social work principles, techniques and practices and their application to complex casework, group work, and community problems. Considerable knowledge of a wide range of medical, behavioral, and/or psychosocial problems and their treatment theory. Considerable knowledge of family and group dynamics and a range of intervention techniques, governmental and private organizations, and resources in the community, laws, regulations, and policies which govern the program. General knowledge of the methods and principles of casework supervision and training. In certain settings, considerable knowledge of medical terminology, disease processes and their treatment as they relate to decisions regarding clinical interventions and appropriate therapies based on medical or psychological diagnosis. Skill in establishing rapport with a client and in applying techniques or assessing psychosocial, behavioral, and psychological aspects of client's problems. Ability to establish and maintain effective working relationships with members of case load and their families, as well as civic, legal, medical, social, and religious organizations. Ability to express ideas clearly and concisely and to plan and execute work effectively.
